How to Enter

2. Each Category or submission requires a minimum donation of \$2.00 cash only for the food banks of Victoria and Sidney and must accompany each submission. (Re: Prize for largest donation- donations will be kept private).
3. Enter as many times as you wish making a donation with each entry & submitting a separate entry form.
4. All submissions must be hard copy photos, not digital. Photo size must be a clear photo either 5X7 or preferably 8x10 and will NOT be returned to you. A digital image may be requested at a later date for contest use.
5. Contest closes at 3pm on December 24th
6. Prizes will be awarded on December 29, 2009
7. Prizes must be accepted as awarded.
